Terms & Conditions

MBF Prevention Education Program customers, facilitators, and other school or organization staff with access to program materials must agree to abide by the following:

- MBF Athlete Safety Matters® (The Program) and all related materials are the sole property of the Monique Burr Foundation for Children (MBF) and are proprietary and under the protection of copyright laws.
- All purchases of The Program include a 3-year license to implement The Program within the purchasing program or organization and a 3-year subscription to the Facilitator Portal and Facilitator Training for the specific number of Facilitators included in The Program purchase and any additional Facilitator subscriptions purchased.
- The Facilitator Portal contains access to the Certified Facilitator Training, the most up-to-date curriculum scripts and PowerPoints, and all other needed program materials.
- Only Certified Facilitators trained by MBF may implement The Program. The **purchasing organization must ensure all Facilitators complete training**. Purchasing organizations may not train facilitators. Additional Facilitator subscriptions may be purchased. Each additional facilitator subscription purchased will receive an individual login to the Facilitator Portal, online Facilitator Training, and customer support.
- Additional facilitator Portal access will expire when the purchasing organization's 3-year subscription expires, regardless of when the additional facilitator subscription was purchased/added.
- Contents on the Facilitator Portal (and the Curriculum Book and Flash Drive) may be reproduced and shared within the licensed organization with Certified Facilitators with an active Facilitator Portal Subscription only. Curriculum materials may not be shared with outside organizations.
- Program lesson materials, including curriculum scripts and PowerPoints, may not be altered without the written consent of MBF. To uphold the fidelity and efficacy of the programs, lessons must be presented as written, in their entirety.
- Program materials may be co-branded with an organization's logo, website, and/or contact information as long as no MBF identifying information or logos are removed and The Program name is not altered or removed. Co-branded materials must be approved by MBF prior to use.
- Reinforcement items are an integral part of The Program. Some reinforcement items must be used with the Program lessons (including Parent Information and Activity Sheets and Safe Adult Club Cards). These items are available on the Facilitator Portal for download and printing or they may be purchased separately from MBF. Other reinforcement items are recommended (including Banners and Student Bag Tags) and may be purchased from MBF. An active license/Portal Subscription is required to purchase reinforcement items.
- MBF Programs are updated on occasion. Updated Program materials will be posted to the Facilitator Portal as they become available. Facilitators with an active Facilitator Portal Subscription will be notified of updates and may access, download, and print updated materials from the Facilitator Portal. No additional purchase is necessary.
- Purchasers and Facilitators of the Programs give MBF the authorization to print/publish the name, city, and state of the purchasing organization.
- Any reference to the use of The Programs must include the Monique Burr Foundation for Children as the developer/owner of the Programs and use the following trademarked names in their entirety (including the "MBF"):

 - Be comfortable presenting the scripted lessons to children and/or teens about the sensitive topics in The Program, such as sexual abuse and human trafficking.
